



Contractual Agreement for Oasis Christian Center, Inc.

By reserving a date at Oasis you agree to the following terms:

Deposits/Cancellations: A deposit is required to confirm your date with Oasis. This \$500 deposit is non-refundable and non-transferable. The deposit goes towards your final balance. **Minimum Charge:** The minimum charge for a one night event is \$1800, two night event is \$2520 and three night event is \$3000. Private lodge rooms are \$20 extra per room on top of the minimum charge. **Tentative Dates:** Tentative dates will be held for five (5) business days while the deposit is being mailed in. After five (5) business days, Oasis will release the dates to be claimed by anyone. **Group Number Responsibility:** An approximate number of persons attending your overnight rental shall be provided at the time of your booking. 10 days prior to your event you will be responsible for contacting Oasis with the final number of people attending and how many private lodge rooms (if any) you will need. **Payment:** 100% of fees due must be paid five (5) days before your event. Please present cash, check, or money order. We do not accept credit cards. **Insurance:** You agree that your organization will cover all insurance costs, and you'll send us a copy of your off site insurance policy. **Alcohol/Drugs/Tobacco/Firearms/Fireworks:** Alcohol, illegal drugs, firearms and fireworks shall NOT be brought on Oasis property. Smoking or tobacco use is not permitted inside any building and must be disposed of in the proper areas. **Schedule:** Oasis is very flexible in working with your schedule. Common meal times are 8am, 12:30pm, and 5:30pm. However, we can accommodate any group meal times you need. We ask that you email an agenda of your event to andy@oasischristiancenter.com. **Medical Releases:** Medical release forms must be provided for all persons of age 17 and under who are attending without a parent or legal guardian. A medical release form can be found on our website and must be turned in immediately upon arrival. **Audio/Video:** Use of the audio/video equipment at Oasis is allowed. If needed, we will assign an Oasis staff member to assist you. Only Oasis staff is allowed in the audio/video room. Contact Andy McClung at andy@oasischristiancenter.com for all audio/video questions. **Lodging:** Adult supervision must be provided for each area where youth age 17 and under are lodged or permitted. Group coordinators are responsible for assigned individual lodging. Oasis reserves the right to reassign lodging and meeting rooms. **Curfew:** Although Oasis does not set a curfew for groups, we ask that quiet hours be maintained in and around the facilities from 10pm to 8am. **Pets:** No pets of any kind are allowed on Oasis grounds. Service animals such as seeing-eye dogs are allowed with proper documentation. **Cleaning Fees/Damages:** Oasis reserves the right to add a cleaning fee or damage fee if necessary. A \$100 cleaning fee will automatically be charged for any non-emergency fire extinguisher fired. Guests are responsible for all damages due to carelessness or abuse. At the discretion of Oasis, we may require an additional security deposit in advance. **Recreational Vehicles:** Go-carts, golf cars, off road equipment and ATVs are not permitted on Oasis property. **Refusal of Service:** Oasis reserves the right to refuse services for any person or group whose activities and practices violate or contravene the principles, policies, or procedures of Oasis, as determined by Oasis Christian Center, Inc. Such refusal of service may take place during the stay at Oasis and may include, in the case of a serious violation, a request to immediately leave the premises. If the person or group refuses the request, all remaining members will be deemed as trespassing as a matter of law. **Property Loss:** Oasis is not responsible for any personal/organizational property lost or left behind. If you leave something behind, you will be responsible for picking it up or the shipping fees. **Internet:** Wireless internet is provided, but not guaranteed in specific buildings. The organization and signer listed below claims full responsibility for all internet usage during your event.
